

Services are individually arranged with the Disability Support Services (DSS) Counselor.

To qualify for accommodations, a student must meet with a DSS Counselor, provide documentation of her/his disability, and work with the DSS Counselor to make arrangements for accommodations. Acceptable documentation of a disability includes: an IEP, a 504 Plan, or a diagnosis as provided by a health care or mental health care professional on office letterhead. It is the student's responsibility to contact her/his instructor to discuss accommodation needs for each class.

It is recommended that students meet with instructors at the beginning of the semester to ensure that their accommodations are available to them throughout the entire semester. Please be aware that failure to do so will likely result in a student not receiving the accommodation.

A memo is sent to the instructor saying the student "may need the accommodation "

The accommodations are intended to help ensure you are as successful as possible in your courses.

Services are available for all future terms as long as the services are directly tied to the current impact of the disability. Updated documentation may be required.

Ask the teacher to send test to the testing center (MC 220/ RC 120) one week before each test.

#### Tape Recorder

Bring a recorder to class and listen to recording after class, writing down important ideas.

#### Note Taker

Ask a fellow student to take notes or ask for assistance in finding a note taker from your instructor. NCR paper is available in the Disability Support Services office (MC 105) or the LAC at the Radcliff Center (RC 120). Review notes the same day several times.

# APPLYING TO SCHOOLCRAFT COLLEGE

- 1) Go to <a href="www.schoolcraft.edu">www.schoolcraft.edu</a>. Up at the top, click on#2 Apply. The first option, in blue font, states "Application for Admission". Click on it and fill out the requested information. Some information is required; other information is optional. If you have an idea of what program you are interested in, indicate it at the bottom (it says "Undecided/General Studies"). (Don't worry if you change your mind this happens often and is easy to do with a program change form in the Disability Support Services office or at the Counseling Center.) If you are planning on using financial aid funds to pay for courses, you must select a program. If you select the last option, "Non-degree Seeking, Undecided", you will likely not receive funding for classes.
- 2) Once you have completed the application, it will take about a week for us to process the application and assign you a student ID number. You should receive a letter in the mail within 10 business days of applying for admissions indicating your status (e.g. whether you have been accepted or not, and the next steps for you to take). If you do not receive a letter within this time frame, please call the Registration Center at 734-462-4426. If you wish to process your application through sooner to get a student ID number faster, call the Registration Center (same process as above), and a representative should be able to help you with this as long as all of the information needed has been provided.
- 3) Schedule an appointment to meet with a Disability Support Services counselor. Call 734-462-4330 to schedule the appointment. For the appointment, you should bring a copy of your IEP, Section 504 plan, or a note on official letterhead from your treating mental health provider stating your diagnosis. You should also bring a copy of your high school transcripts and your ACT scores (if you have any).

If you do not have ACT scores, you will need to take Schoolcraft's placement testing to determine your English, math, and reading proficiency for placement into courses. This usually will not be done on the same day as your appointment. If you are interested in taking the placement testing, please go to <a href="https://www.schoolcraft.edu/lac">www.schoolcraft.edu/lac</a> for links to websites that will provide review and refresher information for these areas. It is STRONGLY recommended that you refresh your math skills (at a minimum; reading and English as well if desired) before taking the placement testing. Our test starts with fractions and decimals and many students are not as current on these skills as they should be to do their best on the placement test. (The goal of testing is not to determine "pass/fail" or to see what you have forgotten or not seen in a while, but to determine the level of skills you possess in English, math, and reading so that we can discuss appropriate class placement – not too hard, and not too easy.)

4) Attend your appointment, set up accommodations, and possibly select courses.

Throughout the school year, informational seminars for incoming high school students are presented. Please see the website for dates and times, or you can call the Disability Support Services office at 734-462-4330 for information. Differences between high school and college will be discussed, as well as how to schedule a meeting to set up accommodations and the timeline for registration. # INFORMATION HIGH SCHOOL STUDENTS SHOULD UNDERSTAND PRIOR TO APPLYING TO SCHOOLCRAFT COLLEGE

- Colleges do not provide personal aides but may assist students in making their own arrangements.
- Generally students are allowed extended time on tests (150%, or time and a half at Schoolcraft), but not unlimited time, depends on curriculum.
- Usually students are not given extra time to complete homework assignments, projects, term papers, etc., unless individual instructors agree to do so. In these cases, those arrangements are made between the instructor and the student -- NOT through the Disability Support Services Counseling office.
- In college, there are no modified assignments, such as shortened length, fewer to complete, etc. All students are expected to complete the required coursework for each class.
- As a college student, FERPA (Family Educational Rights and Privacy Act) covers confidentiality and does not allow parents to access or discuss student information without a signed and dated student release form.
- The typical college schedule demands very different time management skills compared to high school. In general, for every one hour that a student spends in class, they SHOULD spend 2 3 hours OUTSIDE of class, reading the textbook, studying for tests, writing papers and lab reports, solving math problems, etc.
- In college, there are no resource rooms or special education classes; students are encouraged to utilize tutoring services, which are provided free of charge.
- Colleges rely less on human readers/scribes and more on technology.
- Colleges rely on diagnostic information to assist students but do not use the IEP process.
- Documentation requirements vary from one institution to another. It is important to become informed as to what is required at each.
- For student interested in applying for Financial Aid, starting July 1, 2012, any student
  who has NOT earned a high school diploma or their GED will not be eligible for financial
  aid funding.
- Students are required to advocate for themselves. Students need to meet with a Disability
  Support Services Counselor to make arrangements for accommodations best suited for
  their diagnosis and instructors will be provided with accommodation information. It is
  then the STUDENT'S responsibility to speak with each of their instructors about their
  needs in each of their courses.

Initial meetings should be set up sometime during January through March - <u>before</u> students plan on attending in the Fall

What student should bring to the initial meeting:

- Copy of IEP
- Copy of high school transcripts
- Copy of ACT scores (where applicable)
- Any questions that you may have

During the initial meeting, the student and the counselor will discuss the student's diagnosis, their previous accommodations, and ideas about future academic goals (e.g., transferring to a four year college and planning on earning Associate's degree at Schoolcraft; earning a skills certificate at Schoolcraft; seeking the experience of a college education). Accommodations for college courses will be discussed and some paperwork will be completed. If a student will be seeking financial aid, steps should be made to look into the process and start completing the paperwork. (Please speak to someone in the Financial Aid office at 734-462-4433 for additional information. The website for applying is <a href="https://www.fafsa.ed.gov">www.fafsa.ed.gov</a>. Please be sure to apply by the beginning of May to ensure that the application can be processed before early registration for Fall begins.)

Based on ACT scores and a review of their high school transcripts, it will be determined if the student is required to take Schoolcraft's placement exam, or if the student is interested in taking Schoolcraft's placement exam. (Not everyone will need to take the placement exam.) When necessary, arrangements will be made during the initial meeting for them to do so. It is important that placement testing be done <u>PRIOR</u> to registering for Fall courses, as this assists the counselors in determining a student's math, reading, and English proficiency.

Students should then make arrangements to meet with a Disability Support Service Counselor as early as possible. (Early registration for Fall semester usually starts at the end of March. Students will want to come in when it best fits their schedule, but they do not want to wait until the last minute if they want to get the schedule that best fits their needs.) At this meeting, the student and the counselor will set up accommodations, review placement scores, select courses, and create a schedule for the Fall semester. We encourage students to register early for classes – this helps ensure that they get the classes that they want, when they want to be taking them, and with the instructors that they prefer.

The financial aid school year runs from July till the following June. You should apply for financial aid after you/your parents/whoever is claiming you as a dependent have completed taxes for the year (usually by the end of April). It takes about 4-6 weeks for applications to be processed and you to receive a reply (as long as the application was filled out properly and additional information is not required).

You will need to re-apply for financial aid every year that you wish to receive it.

Once you have been granted funding, Financial Aid looks at 2 academic criteria:

- -1- overall GPA of 2.0 or higher
- -2- Satisfactory Academic Progress (SAP) you have successfully completed ("passed") 67% of the credits that you have taken

It is better for you to withdraw from a class than to stay in it and fail it:

At this point, you have are not meeting the minimum GPA criteria – overall GPA is BELOW 2.0 (1.833) and you are at exactly 67% completion (successfully completed 8/12 credits = 0.67). Your funding for future semesters is likely in jeopardy.

At this point, your overall GPA is fine (2.75) and you are at exactly 67% completion (8/12 credits = 0.67). Your funding for future semesters will be intact for now, but you need to be careful that your completion rate does not fall lower than it is now.


#### Course Description

- → List Schoolcraft College's Federal School Code on your FAFSA: <u>002315</u>
- → Sign your FAFSA electronically with your FSA ID, which is available at <a href="www.FSAID.ed.gov">www.FSAID.ed.gov</a>. For Dependent students, both student and a parent will need their own FSA ID.
- → The IRS Data Retrieval tool will be available two weeks after submitting your taxes online starting on February 7, 2016. Schoolcraft College strongly recommends using this option.
- 3. Student Aid Report (SAR) Within a week of completing the FAFSA, the Department of Education will send you a copy of your completed FAFSA, called a SAR. Please review the information for accuracy. You may make corrections at www.fafsa.gov or mail in the corrections on your SAR to the Department of Education.

# Your FAFSA is received by Schoolcraft in 3 - 5 business days and you will receive one of the following emails:

An email notifying you that paperwork is needed to complete your FAFSA. The paperwork needed will be listed on your WebAdvisor under "My Documents."

An email notifying you are not eligible for grants and introducing you with additional funding options.

An email directing you to view your award letter on WebAdvisor to see what grants you have been awarded.

# **Academic Progress Requirements:**

In addition to meeting individual financial aid program requirements, students must be making satisfactory academic progress toward completing a degree or certificate program to receive aid. The Schoolcraft College Academic Progress Policy applies to all students who receive financial aid from any program we administer. Federal regulations require that the policy includes reviewing enrollment periods for which students did not receive aid, as well as the semesters students did receive aid. In general, a student must:

- → Have successfully completed at least 67 percent of all Schoolcraft College credit hours attempted or be a first-time student at Schoolcraft College and –
- → Have a cumulative Schoolcraft College grade point average of at least 2.0 and –
- → Along with transfer credits, have not attempted more than 90 credit hours or 150 percent of the student's official Schoolcraft College academic program requirements.
